Representative Election 2025

The Representative Election for the Student Union of Tampere University will be held as follows:

- Primary election days: 3 November 6 November 2025 at 9:00 18:00
- Preliminary voting: 29 October 31 October 2025 at 9:00 20:00

Anyone who is eligible to vote may cast their vote at any voting event.

In the election, 49 members to the Representative Council of the Student
Union are elected for the term 1 January 2026 - 31 December 2027. The
election follows the standing TREY Election Rule which is on display at the



service offices on the City Centre and Hervanta campuses and the student union website.

Primary election days

Voting is electronic and can be done online. Electronic voting requires you to log into the system with your personal user ID for the University Intranet. If you do not remember your user ID or you encounter any problems when logging in, please contact the university IT-Helpdesk at it-helpdesk@tuni.fi. With any other problems, please contact the Central Election Committee, vaalit@trey.fi.

You can find the voting system at <u>www.trey.fi</u>. The voting system is open on the instructed election periods.

Preliminary voting

Preliminary voting is open on 29 October at 9:00 – 20:00, 30 October at 9:00 – 20:00 and 31 October 2025 at 9:00 – 20:00. You can find the voting system at www.trey.fi.



Eligibility for election

All members of the Student Union who have registered as present are eligible for election, including post-graduate students who have paid the membership fee. Everyone who is eligible to vote is also eligible for election unless the student union rules state otherwise.

Eligibility to vote

All members of the Student Union who have registered as present are eligible to vote, including post-graduate students who have paid the membership fee. In order to be eligible to vote, one must have registered as present 21 days before the election at the latest. Eligibility to vote will be determined based on an electoral register compiled by the University.

Electoral documents

The electoral documents confirmed by the Central Election Committee will be available at www.trey.fi/council-elections from Monday 18 August 2025 at 9:00 onwards. The documents will also be available at TREY service offices on the Centre and Hervanta campuses during their opening hours. The Candidacy Announcement must be electronically logged in with one's university basic user account (tuni.fi user ID).



Electoral alliances must submit the needed amount of candidacy announcements to form an electoral alliance (2 announcements needed) and the preliminary announcement of the electoral alliance by 3 September 2025 at 16:00 if they desire to utilize the student union website for candidate recruitment purposes.

Electoral circles must submit the needed amount of election alliance preannouncements and candidacy announcements to form an electoral circle by 3 September 2025 at 16:00 if they desire to utilize the student union website for candidate recruitment purposes.

The Candidate nomination period ends on 30 September 2025 at 16:00. The end of the candidacy nomination period is the deadline to form electoral alliances and circles. Candidate announcements or electoral alliance and circle agreements submitted after the deadline will not be accepted for the election.

The Central Election Committee will process the documents on 2 October 2025. The documents will not be public until they have been processed by the Central Election Committee.

Electoral documents must also include the names and identifiers of electoral alliances or nonpartisan candidates. The names and identifiers cannot be



commercial, insulting to anyone's personal rights or otherwise inappropriate.

If a name or identifier does not comply with the above regulations, the

Central Election Committee may reject the name or identifier without

consulting the candidates in question. The documents are only valid when signed by an Electoral Spokesperson.

After reviewing the election documents, the central election committee may request the candidate or list to correct erroneous election documents without delay. The central election committee will then reprocess the documents in its meeting on 9 October 2025.

Election Advertising

Election advertising inside campus buildings is allowed from 13 October 2025 onwards. Election advertisements may be attached to the locations designated by the Central Election Committee. The Central Election Committee offers candidates the opportunity to advertise on TREY's election pages. Election advertisements must be removed by Sunday 9 November.

Detailed regulations on election advertising will be available at www.trey.fi/council-elections and at the Student Union service Offices on the City Centre and Hervanta campuses, and from 13 October at 9:00 onwards at the advertising locations designated by the Central Election Committee.



Changes to the Election Notice

organization of the elections. Changes will be communicated without delay.
