

# Etiquette in the Representative Elections of the Student Union of Tampere and guidelines regarding advertising at the University

#### **Distributing advertising material**

Good manners must be observed when conducting election advertising. When placing your advertisements, leave room for other candidates and alliances. That is, do not cover the whole screen with your posters. Movable screens will be provided at each campus for the purpose of placing election advertisements. The University will reserve enough screens for the Student Union to use during the elections. More detailed instructions on the locations of the screens will be provided in early autumn. Advertisements may be placed on these screens only and the advertisements must be relevant to the Representative Elections. The advertisements of other candidates or alliances may not be defaced or covered. Offensive advertisements are strictly forbidden. In student association facilities, the rules concerning election advertising must treat all members of the association equally,



regardless of their electoral alliance or the group they are associated with. If the members of an association are allowed to advertise at the association's facilities, each member of the association or guild must be permitted to place advertisements of their electoral alliance or circle at the facilities. For more information, please contact the association, the faculty association or the degree programme students who are responsible for the room in question.

Advertisements may be distributed in the University entrance halls at the main entrances of buildings and outside University buildings. Campaign activities may not disrupt anyone's passage (either inside or outside) or the use of campus restaurants. Advertising is forbidden during lectures and in lecture rooms. The representative elections may of course be mentioned during lectures, but no particular candidates or groups should be promoted. Those distributing advertisements must ensure that the advertising does not result in littering on university grounds. Passageways may not be blocked by election tents or other structures.



An opportunity to vote may not be offered in connection with election advertising.

# Election-related events at university facilities

Events related to the Representative Elections may be organised at university facilities before the elections. Events may be organised on campus if the event has been authorised by the University.

Events organised in associations' facilities must always be authorised by the association(s) governing the facility.

- Election-related events must be directed at the students and organised by the candidates themselves.
- Electoral panel discussions must strive to represent the existing
  electoral groups equally. Official electoral panel discussions must invite
  all nonpartisan candidates and a representative from each electoral
  alliance. Only approved candidates may participate in panel
  discussions as panellists.



- Election-related events always have an appointed representative of the University house managers as a contact person.

# **Advertising on mailing lists**

University mailing lists may be used only to advertise the representative elections in general. No particular candidates, electoral alliances or electoral circles should be mentioned. The use of the University's electronic communication resources (including email and intranet) is restricted by university guidelines regarding the use of those resources.

# **Equality at the University**

Tampere University and the Student Union of Tampere are committed to the promotion of equality and the prevention of discrimination in everything they do. The environment at the University and the Student Union is one where diversity is respected. Election advertising and election activities may not



insult anyone on the basis of gender, sexual orientation, age, origin, language, religion, state of health, disability or any other personal characteristic. Equality is an everyday feature of a diverse and multilingual university community. Therefore, university facilities may not be used to organise events or to distribute materials that do not comply with these values or where, for example, hate speech, incitement to violence or agitation against a segment of the population occurs, or signs, symbols or images related to those are presented. Voter's freedom of choice must be guaranteed at all times.

# **Health security**

COVID19-related hygiene instructions must be followed at all election events and at the polling stations.
