

Privacy policy and register description of the Biggest Wappu in Finland event registration 2022

This privacy policy is in accordance with the European Union's General

Data Protection Regulation (GDPR). The privacy policy was created on 24

February 2022.

1. Controller and contact person responsible for the register

The Controller of the register is TREY, not an individual staff member or sector.

2. Name of the register

Student Union of Tampere University's (TREY) Biggest Wappu in Finland event registration 2022 register.

3. Legal basis and purpose of processing personal information

The EU's General Data Protection Regulation (Article 6) determines the legal basis for the use of personal information. The legal basis for TREY's Biggest Wappu in Finland event registration 2022 register is a person's consent to processing their personal information. The purpose of processing personal information is to collect events for the Biggest Wappu in Finland and gather information about the event organizers for the purpose of contacting them.



the basis for processing personal information here is:
□ registered person's consent
□ contract
□ performing a task carried out in the public interest/exercise of official
authority vested in the controller, more clearly: -
The information will only be used for the purpose determined in the policy.
If personal information is used for a different purpose than originally
described, the registered person must be informed, and if necessary, their
consent to use the information in any way deviating from the original
purpose must be obtained.

4. Information content of the register

TREY's Biggest Wappu in Finland register contains the following personal information:

 Name of the event organizing body and contact details (name, e-mail address, telegram-nickname)



membership or positions of trust in TREY or relevant associations / organisations

The registered person has the right to request their information to be deleted (section 10, right to remove).

5. Regular sources of information

The information in the register is obtained from fillers of the form by them submitting it.

6. Regular disclosure of information to third-party operators

As a rule, TREY does not disclose, sell, or rent personal information to parties not involved in the association work. TREY will only share information with third parties in the following circumstances:

Personal data can be shared for statistical, scientific, or historical
 research (such as theses), provided the information has been altered



so that the registered person is no longer recognisable. This data use requires applying for a separate permission that obliges the user to comply ethical guidelines of research and instructions of the Finnish Social Science Data Archive.

Your information may be processed by outside service providers or system providers that have a mandate contract with TREY. The handling of personal information is agreed in the contract, but it is not classified as disclosure of information, as the responsibility of handling personal information remains with TREY.

7. Regular disclosure and transferring of information outside the EU or the EEA

As a rule, the information in the register will not be disclosed to any parties outside the EU or the EEA.

8. Time period of storing personal information



The person responsible for TREY's association register will handle the
disposal of personal information in the following manner:
□ Register will be disposed within a maximum of 3 months
□ Register will be archived anonymously without identification data
(anonymisation, all identification data will be completely removed, so
that no identifiable data can be restored, and no new information can be
connected to the material)
$oxed{\boxtimes}$ Register will be archived with identification data (pseudonymisation,
as data is prepared for further storage, it will be pseudonymised and
other strong identification data will be removed)

When data is being processed for the further storage, it will be pseudonymised and the references on the personal data will be removed. Data will be processed within six months after collection process.

9. Principles of register protection



The register is in TREY's electronic system, to which only the persons concerned have access. The personal information in the register will be handled only by Wapputeam, which consists of TREY's events manager and Wappu directors and Teekkari Union of Tampere's minister of culture and wappu secretaries for the purpose determined in section three (3).

10. Registered person's rights

The registered person has the following rights regarding the processing of their personal information and can make requests concerning the use of that information by contacting TREY at toimisto@trey.fi. As the controller, TREY has the right to ask the person requesting the information for proof of identification. The controller will answer the request as decreed in the EU's General Data Protection Regulation, usually within a month.

Right to review and request to correct registered information



Every registered person has a right to review their personal information stored in the register and request possible corrections to false information or to supplement incomplete information.

Right to oppose

A registered person can oppose the processing of their personal information, should they feel their personal information is not handled lawfully, or that TREY does not have the right to process their personal information.

Right to remove

The registered person has the right to ask for the removal of their personal information from the register (right to erasure).

Right to limit the use of personal data

The registered person has the right to request limiting the use of their personal information.

Right to appeal

The data subject has the right to lodge a complaint with the supervisory



authority if the data subject considers that the processing of personal data violates the general EU data protection regulation (EU) 2016/679. In addition, the data subject has the right to pursue other administrative remedies as well as legal remedies.
