

Privacy Policy – Council Elections Candidacy

4. Legal Basis and Purpose of the Processing of Personal Data

The EU General Data Protection Regulation (Article 6) provides the legal basis for the processing of personal data. The legal basis of TREY's Council Elections Candidacy Register is consent of the registrees.

Purpose of personal data collection is to organise the Council Elections according to Election Announcement. Data is used to create a list of candidates and voting aid application. TREY may send requests for vetting and supplementing information about candidates to spokesperson of their Electoral Alliance. TREY may send invites





and reminders about participating in voting aid application. TREY may also send other messages relevanto to Council Elections to the candidates. TREY decides on the information asked in the voting aid application. The information given to voting aid application by candidates and Electoral Alliances is used to organise Council Elections and introduce candidates.

TREY may publish the list of candidates in its communication channels.

The information given to voting aid application is publicly available after the publication of voting aid application.

The results of the elections are published after the results are confirmed.

The information will be used only to the purposes described. If the information will be used for a different purpose than described above, the registrees will be informed and if necessary, a permission will be asked.

5. Information Content of the Register

The register contains the following personal data of the registrees:

Information signed by spokesperson of an Electoral Alliance or Electoral Circle:

- Name
- Phone number
- E-mail address
- Student number

Information signed by a candidate:

- Name
- Date of birth
- Phone number



- E-mail address
- Student number

Information given for publication in voting aid application by candidate:

- Name
- Candidacy number
- Name of the Electoral Alliance and/or Electoral Circle
- Photo
- Age
- Candidate's answers to questions in the voting aid application
- other information given by the candidate to the voting aid application

The data will be retained as long as it is relevant for the Council Elections. Any registree has the right to request the personal information to be deleted **(point 10)**.

6. Regular Sources of Information

The information stored in the register is gotten from the registrees themselves when they submit electoral documents.

7. Disclosure of Information to Third-party Operators

TREY doesn't principally give, sell or rent personal information to operators outside organisational activities. TREY gives information to third-party operators only in the following cases:

• Data can be given for statistical, scientific or historical research purposes. Before this the data must be anonymized to the point that no individual is recognisable.

8. Disclosure and Transfer of Data Outside the EU or the EEA



The information in the register will not be disclosed or stored outside the EU or the EEA.

9. Registry Security Principles

The register is located in TREY's own and self-maintained electronic system in accordance with good maintenance principles/practices. Access to this register is limited to user accounts and passwords. Persons who have user accounts to the system and so access to this register are only selected employees and selected board members of TREY.

The personal information in the register will be handled only by selected employees and selected board members of TREY in accordance with the section four (4).

10. Right of Inspection and Right to Request Correction of Information

Every registree subject has the right to check the data stored in the register and to request the correction or supplementation of any incorrect data. If a person wishes to check the data stored about them or request a correction, the request must be sent in writing to the data controller at toimisto@trey.fi. If necessary, the controller may ask the registree to prove their identity. The controller shall, as a general rule, respond to the request within one month at the latest.

Right to object

Every registree has a right to object the handling of their personal information if they feel that their information is not handled according to law or if they feel TREY has no right to handle their personal information.

Right to remove information

Every registree has a right to request the removal of their personal information from the register.

Right to limit the use of personal information





Every registree has a right to request the limitation of the use of their personal information.

Right to appeal to the supervisory authority

Any registree has the right to lodge a complaint with the supervisory authority if the controller has not complied with the applicable data protection rules.
