

Register and Privacy Statement for the Representative Election

This is a Privacy Statement written according to European Union General Data Protection Regulation (GDPR). The Privacy Statement was updated on 10 August 2024.

3. Name of the register

Register for the Representative Election of the Student Union of Tampere University

4. Legal basis and the purpose for processing personal data

European Union General Data Protection Regulation (article 6) states the legal basis for processing personal data. The legal basis for the candidate register for the TREY Representative Election is the individual's consent to their personal data being processed.

The purpose for the processing of personal data is to implement the student union Representative Election as per its Election Rule. The data on the register shall be used to make the combinations of candidates and the voting advice application for the election and to hold the election. TREY may send the contact person for the combination of candidates requests to review and supplement the combination of candidates and any data a candidate has given for making the combination of candidates. TREY may send the candidates of the Representative Election invites to and reminders of the voting advice application and other messages regarding the implementation of the election.

TREY shall determine the information requested in the voting advice application. The data from the combinations of candidates and the data given to the voting advice application by the candidates shall be used at the TREY Representative Election to implement the election and introduce the candidates.

The combination of candidates shall be published in communication channels decided by TREY.

The data a candidate fills into the voting advice application will be publicly available after the application has been published.

The results of the election shall be published as per the Election Rule after the results of the election have been confirmed.

The data shall only be used for the purpose defined in this statement. If the data should be used for another purpose than that originally described, this must be communicated to the data subject and, if necessary, their consent must be obtained.

5. Data content on the register

When filling in the forms, the following data shall be recorded in the candidate register for the Representative Election:

Data signed by the Electoral Spokesperson and their deputy:

- Name
- Phone number
- Email
- Student ID number

Data on a candidate:

- Name
- Date of birth
- Phone number
- Email
- Student ID number
- Degree level
- Starting year of studies

- Gender

Data a candidate gives to be published in the voting advice application:

- Name
- Candidate number
- Name of their electoral alliance and/or circle
- The candidate's responses to the questions on the voting advice application
- Other data the candidate has given to the voting advice application themselves

The data shall be stored for as long as TREY deems necessary. A data subject has the right to request their data be erased from the register (section 10).

6. Sources

All data on the register is received from the subject themselves when they fill in a form.

7. Regular data disclosure to third parties

As a rule, TREY does not disclose, sell, or rent personal data to parties not involved in association activity. TREY shall only disclose data to third parties in the following

cases: Personal data may be disclosed for journalistic, statistical, scientific, or historical research presuming that the data subject has been made unrecognisable.

TREY hands over candidates', electoral spokespersons' and their deputies' emails to Tampere University for the trey-ehdokas@lists.tuni.fi (the candidates) and trey-asioitsija@lists.tuni.fi (the spokespersons and deputies) email lists used for election informing purposes.

TREY hands over the candidates' names and candidate numbers to Tampere University for the voting system. The information of those entitled to vote is extracted from the student system within the framework of the election rules, and the voter's name and username are recorded in the election system.

8. Regular data disclosure and data transfer outside the EU or the EEA

As a rule, personal data shall not be disclosed outside the EU or the EEA.

9. Principles of register protection

The register is kept in the TREY electronic system which only the appropriate TREY employees have user ID's, passwords and access rights to. Only TREY employees shall process the data for the purposes determined in section four (4) of this statement.

10. Rights of the data subject

The data subject has the following rights regarding the processing of their personal data, the exercising of which must be requested at: toimisto@trey.fi. As the data controller, TREY has the right to demand the person making the request prove their identity. The data controller shall respond to the client within the time frame decreed in the EU General Data Protection Regulation, as a rule within a month.

Right of access and right to demand the correction of inaccurate data

Each data subject has the right of access to their recorded data in order to inspect it. They also have the right to demand any inaccurate data be corrected or deficient data be supplemented.

Right to object

The data subject has the right to object to the processing of their personal data if they feel that their personal data is not being processed in accordance with the law or that TREY does not have a right to process their personal data.

Right to erasure

The data subject has the right to request their personal data be erased from the register (the right to be forgotten in a digital environment).

Right to restrict the processing of one's personal data

The data subject has the right to demand the processing of their personal data be restricted.

Right of appeal

The data subject has the right to appeal to the Data Protection Ombudsman if they feel that TREY is not processing their personal data correctly and appropriately.
