## 4. Legal basis and purpose of processing personal information

TREY's research activity provides TREY with current information to develop its activities and support its advocacy work through surveys and reports.

The purpose of processing personal information is to carry out and support the research activity with surveys and reports that are targeted towards the Student Union of Tampere University's members, associations operating under it, interest groups, and people in positions of trust and staff at TREY. The objectives of each piece of research are defined separately and potential respondents are informed of them. TREY's research activity carries out both anonymous surveys and surveys where personal information is collected. This privacy policy focuses on anonymous surveys.

In the survey we will collect personal data from the participants which may make it possible to identify people indirectly. These details will only be used as background information for the study, and the participants cannot be identified in the research reports or publications.

The EU's General Data Protection Regulation (Article 6) determines the legal basis for the use of personal information. The legal basis for processing personal information is the consent of the registered person.

The information will only be used for the purpose determined in the policy. If personal information is used for a different purpose than originally described, the registered person must be informed, and if necessary, their consent will be asked.

# 5. Information Content of the Register

In the Student Union of Tampere University TREY's Coronavirus survey for students 2021 you have been asked following information which may make it possible to identify you directly. The individual pieces of data will not directly reveal your identity,





but together the data might convey your identity to the researchers. Data that will be collected:

- A person's age group
- A person's gender
- Details about a person's studies (primary study campus, faculty, study year, exchange study status, current study phase, full-time studies)
- Person's language of business in the university

You may also provide details in the open fields that make it possible to identify you indirectly. Any registered person has the right to request their personal information to be deleted (section 11).

## 6. Regular Sources of Information

The information stored in the register is gotten from the registrees themselves when they submit the survey.

# 7. Disclosure of Information to Third-party Operators

Data will be anonymized and analysed before being shared. No individual registree will be recognisable from the shared information. TREY will only share information with third parties in the following circumstances:

Personal data can be shared for statistical, scientific, or historical research, provided the information has been altered so that the registered person is no longer recognisable. Separate permission will be required for obtaining TREY's data from the controller. This permission obligates its receiver to abide by the ethical principles of research activity and guidelines of the Finnish Social Science Data Archive.



## 8. Disclosure and Transfer of Data Outside the EU or the EEA

The information in the register will not be disclosed or stored outside the EU or the EEA.

## 9. Storage time for personal information

The information will be processed for further storage within six (6) months from carrying out the research.

# 10. Principles of register protection

TREY does not store manual records of the personal information collected during research.

The register is stored and protected in TREY's electronic system, to which only the people who need the information in their work have access. The personal information in the register will be handled only by selected employees and board members of





TREY for the purpose determined in section four (4). These people have the requisite usernames and passwords. TREY's workstations and stored media are password-protected.

# 11. Registered person's rights

The registered person has the following rights regarding the processing of their personal information and can make requests concerning the use of that information by contacting TREY at: toimisto@trey.fi. As the controller, TREY has the right to ask the person requesting the information for proof of identification. The controller will answer the request as decreed in the EU's General Data Protection Regulation, usually within a month.

Right to review and request to correct registered information

Every registered person has a right to review their personal information stored in the register and request possible corrections to false information or to supplement incomplete information.

### Right to oppose

A registered person can oppose the processing of their personal information, should they feel their personal information is not handled lawfully, or that TREY does not have the right to process their personal information.

### Right to remove

The registered person has the right to ask for the removal of their personal information from the register (right to erasure).

## Right to limit the use of personal data

The registered person has the right to request limiting the use of their personal information.

## Right to appeal

The registered person has the right to make a complaint to the Data Protection Ombudsman, if they feel TREY is not handling their information in a correct and proper manner.
